Satsuma Community Development Organization is proud to announce the opening of nominations for our Satsuma Citizen the Year Award 2016. The purpose of this award is to recognize an individual who has made significant civic contributions to the quality of life in the Satsuma community through his or her personal volunteer efforts. ONLY VOLUNTEER SERVICE TO SATSUMA CAN BE CONSIDERED.

Candidates for this award may be nominated by Satsuma citizens, clubs, organizations, churches, or civic groups. A recommendation letter and resume' recounting the nominee's service to the community must accompany the official nomination forms, which are available at Satsuma City Hall. They also can be downloaded from www.cityofsatsuma.com. Completed nominations should be put in a sealed envelope and placed in the nominee box located at city hall by February 27, 3:30 p.m.

Persons considered for Citizen of the Year must meet these requirements:

- Nominees should be a resident of Satsuma for all of 2016.
- They should be nominated for their volunteer service provided to the community of Satsuma.
- All city memberships and offices held, along with year of service in each area, should be included.
- Service is generally based on a period of the last five years, as well as past achievements and ongoing contribution to the community.
- Completed nomination forms with requested materials should be turned in no later than Monday, February 27.

All nominees will be honored during the Citizen of the Year Dinner at Steele Creek Lodge, Thursday, March 30, at 7:00 p.m. All nominees will receive two tickets for the event and have a table reserved for them. Tickets for the dinner are \$15 and will be available for purchase by Monday, February 20. The price of admission will include dinner and saxophone music by Leonard Houston.
