# Special Recognition: NONE

### Visitors:

• Terry Sullivan, 5323 W. Hummingbird Drive, came before Council to complain about the junk cars in his neighborhood and the mother-in-law suites. Mayor Williams asked the location of the junk cars. Mr. Sullivan stated that they were in the residents back yards. Mayor Williams stated that the City has limited authority unless the nuisance is creating a health hazard. Mayor Williams also stated that if the mother-in-law suites are livable accommodations and meets the zoning ordinance it is allowed.

# Mayor's and Council's Reports:

1. Report on the contract with Ben Radcliff Construction for the Public Safety Building.

Mayor Williams reported that the City was expecting to close on a construction loan shortly after the bid was accepted. However the City was informed that a bond will have to be prepared and this is going to take more time. He stated that after discussing the matter with United Bank and the bond attorneys, they have scheduled a closing for July 30<sup>th</sup> and the loan should be funded on July 31st. Because of this the start date has been changed to September 1, 2018.

**Municipal Services- Councilmember Little** mentioned that he received a memo from Bridgett in Public Works stating that a resident on Vaughan Drive called in and gave a compliment to the garbage truck driver. She stated that she was pushing out her cart and it rolled over. She stated that the driver of the truck stopped and helped her get the cart to the road.

**Public Safety- Councilmember Butler** reported that he did not have any items to bring before the Council.

Administration-Councilmember Skelton reported that he did not have any items to bring before the Council.

**Parks- Councilmember Cross** reported that she did not have any items to bring before the Council.

**Public Works- Councilmember Black** reported that Public Works employees are doing the summer routine work.

# **ITEMS FOR CONSIDERATION**
