1. **PAVILION RESERVATION DOES NOT RESERVE THE RESPECTIVE PLAYGROUND OR SPLASH PAD.** ALL City of Satsuma playgrounds and the splash pad are open to the public, unless closed for maintenance.
2. The pavilion may be rented after you so please be mindful of groups that may be utilizing the pavilion when your time period has expired.
3. Splash Pad Attendants will be available to assist with any needs or questions. If the attendant is not available, please make sure that all garbage is put in the trash receptacles and ready for the next group.
4. Full payment is due when the event is reserved. Reservations and payments are to be made, in person, at Satsuma City Hall. No over the phone reservations will be made. Payment can be made by cash or check. If payment is made by check, payment must be made at least ten (10) days prior to the event. You will receive a copy of your rental form from the City. Please have it as your proof of reservation. If someone refuses to leave your reserved pavilion during your scheduled time, see the Splash Pad Attendant or contact the Satsuma Police Department at (251) 675-0151.
5. Pavilion rental is available; Monday- Sunday from 9: a.m. until 8:00 p.m. Please contact Edith Butler at 675-1440 ext. 2. The pavilions are located behind the Splash Pad and include the following amenities:
 - ✓ Three 8' Picnic tables
 - ✓ One small grill per side
 - ✓ Power outlets
 - ✓ Access to hand wash sink
 - ✓ Two Ceiling fans per side
 - ✓ Restrooms located nearby

AGREEMENT

As a renter of the Satsuma Splash Pad, I agree to abide by all City of Satsuma policies for site use (listed below) and to be liable for all damages to any area of the facility and any of its contents or grounds that result from my use of the site under this Agreement, provided such damages are not caused by any overt act or omission of an agent or employee of the City of Satsuma.

I understand that the rental may be canceled due to inclement weather, mechanical failure or any safety issue. Should a suitable alternative date not be available, a full refunded will be issued.

I also agree that the City of Satsuma shall not be liable for the renter, or any of the renter's employees, patron, members, visitors, or guest for an injury or damage to persons or their belongings which result from or during the use of the facility under this Agreement, except as may be caused by an over act or omission by an agent or employee of the City of Satsuma.

SATSUMA SPLASH PAD RULES AND REGULATIONS

- City of Satsuma staff complies with Mobile County Health Department regulations.
- No Vehicles are allowed to be parked in grassy areas behind the splash pad.
- Children under the age of 12 must be accompanied by an adult.
- Swimsuits and/or appropriate attire must be worn at all times. Cut-offs, gym, or dress shorts including thongs and transparent colored suits are prohibited.
- Children not toilet-trained must wear a swim diaper. Regular disposable or cloth diapers will not be allowed
- No person under the influence of drugs or alcohol will be allowed inside the fenced area.
- Glass containers are prohibited within the fenced area.
- Food and drink are not allowed in on the splash pad at any time.
- Smoking and tobacco products are prohibited in the Park.
- Pets are prohibited within the fenced area.
- Bicycles, scooters, skates, and skateboards are prohibited on the splash pad
- Running and horseplay are prohibited on the Splash Pad.

- Persons must conduct themselves in a courteous, safe, and family-oriented manner. The use of profanity or abusive language, symbols or gestures may result in removal from the Splash Pad without a refund
- Lawn chairs, balloons, athletic equipment, balls, bats, beach balls, noodles, etc. are not allowed inside the fenced area.
- In the event of threatening weather, the Splash Pad will be closed. We ask that persons go to a safe area. A safe area may be your car or your home.
- The City of Satsuma reserves the right to remove participants for violating any of the above rules or engaging in illegal, disruptive, destructive, or inappropriate behavior without refund
- The attendant will have the authority to regulate the maximum number of users allowed on the Splash Pad.
