Mayor Williams thanked Ashley Lankford and Ben Luker for their service and wished them well in their future endeavors. He then proceeded to introduce the new Jr. Councilmembers Reagan Nolfe, Tyrek Cunningham, Emma Rawls and Ryleigh Rawson.

### **RESOLUTION NO. 2019-08-03**

#### A RESOLUTION APPOINTING VALENDA LANKFORD TO THE BOARD OF EDUCATION FOR THE SATSUMA CITY SCHOOL SYSTEM

WHEREAS, the City of Satsuma, Alabama (the "City") created a Board of Education ("BOE") pursuant to Alabama Code § 16-22-2, et seq. (1975);

WHEREAS, the City has resolved to appoint five (5) residents of the City of not members of the City Council, and who were chosen upon their Satsuma, who are character and fitness, to serve as the initial members of the BOE; and

WHEREAS, one of the members, Elizabeth Nations was appointed in March of 2019; and

WHEREAS, Elizabeth Nations tendered her resignation effective July 9, 2019 and her resignation was accepted by the City Council on June 8. 2019; and

WHEREAS, the City Council conducted interviews in a scheduled work session on July 22, 2019 of other qualified applicants that had completed an application by the due date of July 11, 2019, and;

WHEREAS, the City Council now wishes to appoint Valenda Lankford to serve the remainder of the five (5) year term of Elizabeth Nations which will continue until April 30, 2024.

#### NOW. THEREFORE. BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SATSUMA, ALABAMA, AS FOLLOWS:

- Valenda Lankford is appointed to fill the remainder of the term vacated by Elizabeth Nations which expires on April 30, 2024.

# Mayor's and Council's Reports:

### Mayor's Report

- 1. Update on the Sally Port and sidewalks at the Public Safety Building. Mayor Williams stated that both items were discussed in length in pre-Council. He stated that there was cost reduction of the Sally Port from \$55,000 to \$49. 000 and that the foundation should be poured in the next couple of weeks with the structural steel and roof to follow soon after. Mayor Williams reported that after inspection of the sidewalks, it was determined that some of the sections did not meet ADA standards. He stated that the contractor has agreed to re-pour those sections that are in the route of entry.
- Report on Cedar Street /Maple Avenue Right of Way and Drainage Project. Mayor Williams reported that James Elmore has engaged Mobile County to come and clear the right of way beginning this upcoming weekend. After the completion of the right of way cleaning, the County will then proceed to work on the Cedar Street drainage ditch. . Mayor Williams stated that the only cost to the city will be for the operators.

3. Distribution of the June financials. Mayor Williams distributed the June financials.

Municipal Services- Councilmember Little reported that Cedric Dennis whose resignation was accepted at the last meeting has reconsidered his decision and decided to remain with the City.

Public Safety- Councilmember Butler reported that the fire department received a check from the Mobile County Volunteer Association in the amount of \$15.782.61.

Administration-Councilmember Skelton extended condolences on behalf of the Mayor and Council to the families of Sina Harrell, Rosalie Howley, Gerald Gatlin and Jim Meriwether. Councilmember Skelton stated that Ms. Harrell was the oldest resident of the City. Mayor Williams stated that Mr. Meriwether was one of the original members of the Civitan Club of Satsuma.

### Parks- Councilmember Reese reported the following:

- 1) The monthly Municipal Dinner will be held in Citronelle on August 15th.
- 2) Tom Briand is working on getting a price for installing a grinder pump at Wright Park to help with the plumbing issue. Also Mr. Briand is getting a quote to change the lighting at all the ballfields at Lions Park to LED.
- 3) Fall Ball sign up will begin August 17, 2019
- 4) CMO leadership class will be October 3<sup>rd</sup> in Prattville

Councilmember Reese reported that she has gotten information to change out the flag poles at the North and South end of the City. Each end will get a new 30' pole with 2 smaller poles on each side. Each entrance will have an American Flag, Alabama State Flag and a Satsuma City Flag. She stated there is some concern with the power poles on the North End being too close to the power lines. Mr. Briand will meet with Alabama Power to see if there is a problem with the taller flag pole. The cost of this project will be discussed for the FY2020 budget.

Public Works- Councilmember Black reported that there is another tree issue at the end of Painter. The tree is very large and is splitting. He stated that Mr. Elmore will be getting quotes for the next meeting.

## ITEMS FOR CONSIDERATION

1. Payment of the bills.

Councilmember Skelton made a motion to pay the bills in the amount of \$265,371.09 which includes a \$244,106.00 payment to Ben Radcliff. Councilmember Reese seconded the motion and it carried.

2. Consideration of two quotes received to remove two dead trees in the 5th Street right of way.

Councilmember Reese opened two quotes and read as follows:

Reed Tree Service \$925.00 Hammco Tree Service \$987.00

She then made a motion to accept the lowest responsible quote of \$925.00 from Reed Tree Service. Councilmember Little seconded the motion and it carried.

3. Consideration of request for discontinuance of garbage for property at 55 Brice Avenue. Home is vacant.

Councilmember Little made a motion to approve the request. Councilmember Butler seconded the motion and it carried.

- 4. Consideration of training request from Heather Davis to attend the Alabama Municipal Court Clerks Conference - September 18, 19, & 20 at a cost of approximately \$1000.00.

Councilmember Reese made a motion to approve the request noting that the \$100 clean up fee will apply. Councilmember Little seconded the motion and it carried.

# 2. Consideration of Resolution 2019-08-02- A Resolution to purchase a new Pierce Fire Truck

Councilmember Skelton explained that the city was presented an opportunity to apply for a USDA long term loan at a low interest rate. After many discussions on the matter, it was the consensus to purchase a new Pierce Truck for \$441,000; however the price quoted did not include ear protections. Therefore the resolution states that the cost of the truck will not exceed \$450,000 which will include ear protection. Mayor Williams explained that the loan will be paid from the \$1 month contributions and he hopes that more citizens will increase their monthly contributions so that the truck can be paid off sooner. With no further comments, Councilmember Skelton made a motion to adopt Resolution 2019-08-03, Councilmember Little seconded the motion and it carried.

#### **RESOLUTION 2019-08-02**

#### A RESOLUTION FOR THE PURCHASE OF A NEW FIRE TRUCK FOR USE IN THE SATSUMA FIRE DEPARTMENT

WHEREAS, the City of Satsuma has determined a need to purchase a new fire truck for the Satsuma Fire Rescue Department; and

WHEREAS, the City has reviewed the needed specifications and bids and has elected to purchase the Pierce Manufacturing Pumper Apparatus Fire Truck from Emergency Equipment Professional, Inc. offered under the HGAC competitive contract; and

WHEREAS, the Fire Truck cost is \$441,988,00 as per the current specifications required by the Satsuma Fire Department, and

WHEREAS, at the council meeting of June 27, 2019, Councilmember Randy Little made a motion to adopt Resolution 2019-06-03 agreeing to finance the fire truck through United Bank for 25 years at a rate not to exceed 4.25%. Said motion was seconded by Councilmember Reese and passed unanimously.

#### **NOW THEREFORE BE IT RESOLVED** by the City Council that:

- 1. The City approves the purchase of a new Pierce Manufacturing Pumper Firetruck for a total sum 441,988.00 and further approves additional add-on options selected by the Satsuma Fire Department so that the total cost of the truck with all additional add-ons will not exceed a total purchase price of \$450,000.00 from the \$1 month fund.
- 2. The City agrees to finance the fire truck for a term of 25 years at a financing rate not to exceed to 4.25% per annum.
- 3. The City authorizes the Mayor to execute the appropriate documents to secure a short term warrant/note from United Bank for the vehicle.
- 4. This Resolution to become effective immediately upon adoption by the City Council.
