Mayor Williams presented the minutes from the Regular Meeting held on November 19, 2019. Councilmember Skelton made a motion to approve the minutes as presented. Councilmember Butler seconded the motion and it carried.

Mayor 's and Council's Reports:

Mayor's Report

Mayor Williams reported the following:

- Letter was sent by Jay Minus to EDT regarding the flooring in the fire bay at the new Public Safety Building. He stated that EDT has responded and it not accepting responsibility. Ben Radcliff is asking for a final payment. In pre-council, it was discussed to proceed with the payment to Ben Radcliff, to send another letter to EDT and mark off areas with tape.
- The FY2019 is 75% complete and the city was presented with a \$8,625.00 invoice will be in the bills to be paid.
- The WWII Dinner will be held December 18th at 6 P.M. He stated that tickets are \$25.00 each.
- The SARPC annual meeting will be January 16th and 17th at Point Clear.
- He has concerns with the 7th Street sidewalk project. He will be contracting Alan with Civil Southeast to come to the next council meeting to discuss the project.

WHEREAS, on December 3, 2019, the City Council, of the City of Satsuma, Alabama, held a Public Hearing on the City of Satsuma's Notice of Abatement on the properties defined below and found and determined after a public hearing on December 3, 2019, that the structure (s) on the below properties are in violation of the Satsuma Ordinance 377 Sections 58-5 and 58-6; and

WHEREAS, said violations constitutes a public nuisance; and

WHEREAS, said structure(s) unsafe conditions should be removed to protect the public health and welfare of the citizens of Satsuma; and

WHEREAS, the owner(s) of record has been notified by certified mail and posting of the property of said unsafe conditions in accordance with the Satsuma Ordinance 377-58-10, as adopted by the City of Satsuma; and

WHEREAS, the owners of record have been given the opportunity to abate said unsafe conditions and eliminate this public nuisance, yet has failed to do so.

THEREFORE, BE IT RESOLVED BY THE City Council of the City of Satsuma, in the State of Alabama, that the City of Satsuma is hereby authorized to abate said code violation(s) on the below described lots at City expenses and the costs of the abatement shall constitute a lien on the property and shall be collected in a manner provided by law Satsuma Ordinance 377 Section 58-13 and 58-14, and after seven (7) days from the date of publication of this Resolution, the Mayor is hereby authorized and directed to award any contract required for such abatement per Section Satsuma Ordinance 377-58-12.
