Invocation

Approval of Minutes

Mayor Williams presented the minutes from the Regular Meeting held on January 21, 2020. Councilmember Skelton made a motion to approve the minutes as presented. Councilmember Little seconded the motion and it carried.

Annette Marshall of 5729 Apache, came before Council to complain about the serious cat population at her neighbor's home. She stated that she came before Council previously with this same issue and the situation still exist. Mayor Williams stated that the City has an agreement with Mobile County Animal Control but unfortunately, they will only pick up dogs and there are no resources to pick up feral cats. Mayor Williams referred to Chief Harrell. Chief Harrell told Ms. Marshall that she could come in and file a complaint and then the responsible party will have to come and address the matter in court.

Mayor's Report

Mayor Williams reported December, 2019 financials were distributed at the work session held on Monday.

Municipal Services- Councilmember Little stated he did not have any items to report or for discussion.

Public Safety- Councilmember Butler stated he did not have any items to report or for discussion.

Administration-Councilmember Skelton stated that in the work session, he discussed considering putting a signature line for the fire inspector on the Certificate of Occupancy for commercial buildings.
