Regular Meeting

Invocation

Mayor Barlow welcomed everyone and reminded everyone in attendance to maintain social distancing and to turn all cell phones in the off position.

Rev. Steven Norman of Satsuma First Assembly of God led the invocation and Pledge of Allegiance.

A quorum was present and Mayor Barlow opened the meeting for the transaction of business.

Agenda

On a motion to amend the agenda made by Councilmember Skelton and seconded by Councilmember Reese to add item 9j to the agenda. With a roll call vote the following answered as follows:

Approval of Minutes

Mayor Barlow presented the minutes from the Regular Meeting held on September 7, 2021. Councilmember Jason Skelton made a motion to approve the minutes as presented. Councilmember Phillips seconded the motion and the motion carried unanimously.

Visitors

Mike Davis of 400 Burning Tree Drive came before Council to discuss the Arts n Crafts in the Square to be held on December 4, 2021 at 8A.M.

Cassandra Sanders of Missionary Baptist Church came before Council to discuss the property located at 54 Bradford Avenue and the conditions of mentioned property. Mayor Barlow stated that the Tom Briand had been in contact with the owner and had discussed the issue. He also stated that the owner had been cited previously by the Building Inspector. Mayor Barlow asked that they give Council time to review everything and move forward with what Mr. Briand was currently doing.

Mayor's and Council's Reports:

Mayor's Report

Mayor Barlow expressed his condolences to several families on the death of their loved ones throughout the City of Satsuma.

Mayor Barlow reported that on September 20, 2021 there was a meeting held at Steele Creek Lodge to discuss the water and sewer project for the westside of I65 service road.

Mayor Barlow stated a budget workshop was held on September 16, 2021 to work on the budget for FY 2022.

Mayor Barlow reported that debris piles are still being bigger than the city can pick up. at one time and asked for sample ordinances from other municipalities.

Public Services – Councilmember Little

Councilmember Little reiterated that the service for debris pick up is a good idea and we need to keep doing this but with dumping fees becoming very expensive, he is requesting that the maximum of 2 cubic yards be picked up per household as our current policy states.

Public Safety – Councilmember Butler

Councilmember Butler was absent.

Administration – Councilmember Skelton

Councilmember Skelton stated that he and Heather Davis had been working on the budget and we will need to set a budget workshop for September 30, 2021 at 5:30P.M.

Parks & Recreation - Councilmember Reese

Councilmember Reese reported that it was agreed to discuss in the upcoming workshop the American Rescue Plan money and the allocation of such.

Councilmember Reese stated that the next municipal dinner would be in Semmes Alabama on October 21, 2021. Councilmember Reese also stated that the November meeting is hosted by Satsuma and plans need to be put into place to hold this event.

Councilmember Reese reported that there will be a tournament at Wright Park and Crystal Johnson with Public Works has already gotten additional port o lets ordered as well as the grass cut.

Councilmember Reese stated that the entrance signs to the City are still being looked into for renovations.

Councilmember Reese stated the library was having some issues with an A/C Unit..

Councilmember Reese reported the door at Lyon's parked has been taken care of for repairs.

Councilmember Reese reported that Saturday October 23, 2021 the Halloweenie parade will take place again this year.

Public Works – Councilmember Phillips

Councilmember Phillips expressed his appreciation to Crystal Johnson and the employees in public works for keeping the drainage working with the increased rain received.

Councilmember Phillips reported that day to day maintenance throughout the city was being done to keep limbs cut low and potholes filled.

RESOLUTION #2021-09-01

A RESOLUTION TO ADOPT RULES AND REGULATIONS OF SATSUMA'S DOG PARK

WHEREAS, the City of Satsuma has recently constructed a new Dog Park within Magnolia Park for the enjoyment of the residents of Satsuma and their dogs; and

WHEREAS, the City Council desires to establish specific rules and regulations for the protection of its citizens, Dog Park invitees, and their pets while utilizing the Dog Park.

NOW, THEREFORE, IT IS HEREBY RESOLVED that the City of Satsuma hereby adopts the following rules and regulations for use of the City of Satsuma's Dog Park:

- 1. The City of Satsuma Dog Park is for the use of residents and their pets only.
- 2. Owners are legally responsible for their dogs and injuries caused by them.
- 3. All puppies and dogs must be properly licensed, vaccinated and healthy to use the park.
- 4. All puppies and dogs must wear a collar and ID tags at all times while utilizing the park.
- 5. Owners must clean up after their dogs.
- Dogs and puppies showing aggression towards other people or animals must be immediately removed from the park.
- 7. Animals exhibiting a history of aggressive behavior will not be permitted inside the park.
- 8. Puppies must be at least four months old to enter the dog park.
- 9. Owners are not permitted under any circumstances to leave their dog(s) unattended.
- 10. Children under the age of 16 are not permitted in the park unless they are actively supervised by a parent or guardian who is also within the dog park.
- 11. Dogs in heat are not allowed inside the park.
- 12. No food, beverages, glass, sharp objects or weapons are permitted inside the park.
- 13. Owners must carry a leash at all times. Dogs and puppies must be leashed before entering and prior to leaving the park.
- 14. Violators will be subject to removal from the park or possible revocation or suspension of the dog park privileges.

15. All Park invitees will abide by these rules while utilizing the Dog Park but are subject to the requirements of the
rules outlined in the Satsuma Ordinance 520 (on Animals) Sections 10-30 through 10-35 at all other locations.
