Mayor's Report

Mayor Barlow reported that the Preconstruction meeting for the RAA project was held earlier today and the project should be completed by Thanksgiving.

Mayor Barlow reported that sidewalk bids would be opened on October 19, 2022.

Mayor Barlow stated James Elmore and Travis Jones got some quotes on the netting for Lions Park. He has asked them to explore some more options.

Mayor Barlow reported that the deposit has been sent to Explosive Signs for the new directional signs throughout the city.

Public Services – Councilmember Little

Councilmember Little reported that the Seniors are still having approximately 12-15 people on Tuesday and Thursday. Meals on Wheels delivered 1012 meals and the van made 51 trips to various places.

Councilmember Little stated that everything in the Sanitation Department seemed to be going well.

Councilmember Little stated he was optimistic with the Building Inspector position and looks forward to finding someone for the position.

Public Safety – Councilmember Butler
