ORDINANCE NO. 482-5

An ordinance amending The Zoning Ordinance of the City of Satsuma, Alabama (Ordinance No. 482) (hereafter referred to as the "Zoning Ordinance") to further promote the health, safety, and welfare of the citizens of the Satsuma, Alabama.

WHEREAS, after posting by public notice fifteen (15) days in advance The City of Satsuma Planning Commission held a public hearing on May 2, 2024, and voted unanimously at its meeting thereafter to recommend and report to the City Council that the Zoning Ordinance be amended as hereinafter provided; and

WHEREAS, after posting by public notice fifteen (15) days in advance the City Council of the City of Satsuma held a public hearing on May ________, 2024, and voted unanimously at its meeting to adopt the following amendments to the Zoning Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SATSUMA, ALABAMA, THAT THE ZONING ORDINANCE IS HEREBY AMENDED, AS FOLLOWS:

I. SECTION 4.3 OF THE ZONING ORDINANCE IS AMENDED AS FOLLOWS:

4.3 <u>MINIMUM SETBACKS</u>. The following front, rear, and side yard setbacks, in feet, shall apply in districts as listed *and shall supercede any heretofore published requirements in other City Ordinances*, except as provided for in Article III, Section 3.4 and Article V, Planned Unit Developments of this Ordinance.

IV. Effective Date: This Ordinance shall be posted immediately in four (4) places within the municipality (including the Mayor's office) for no less than thirty (30) days. In addition, this Ordinance shall be placed on the City's website for no less than thirty (30) days. This Ordinance shall take effect and be in force on the fifth (5th) day after posting.
