Mayor Barlow presented the minutes from the Regular Meeting held on February 4, 2025. On a motion by Councilmember Little and seconded by Councilmember Phillips, with all voting "aye" Council unanimously approved and the motion carried.

# **Visitors**

Birdie Jones came before the council to discuss the use of Steele Creek lodge on April 28, 2025 and would like the fee waive for the lodge and the cleaning fee. On a motion by Councilmember Phillips and seconded by Councilmember Skelton, with all voting "aye" Council unanimously approved and the motion carried.

Dr. Bill Williams, University of South Alabama, came before council to discuss the Coastal Weather Research Center. Dr. Williams stated the Coastal Weather Research Center is a self-supporting division of the University of South Alabama and is a full-service weather forecast, and climate center located on the main campus in Mobile, Alabama. Dr. Williams stated the Weather Center is able to monitor world-wide weather activity through an array of computer that display the latest satellite and radar imagery along with data products. Dr. Williams stated the Center focuses solely on the meteorology of weather events resulting in longer range projections for its subscribers. Dr. Williams stated the price for the service is \$250.00 and month or \$3,000.00 a year. Mayor Barlow asked Dr. Williams to send a contract over and it will be presented at the council meeting in two weeks.

Wes Vickers, Satsuma Boys Baseball, came before council to announce opening day on March 8, 2025. Mr. Vickers stated the league has 180 registered kids this year which is 40% higher than last year.

# Mayor's and Council's Reports:

#### Mayor's Report

Mayor Barlow expressed his condolences to several families on the death of their loved ones throughout the City of Satsuma.

Mayor Barlow stated South Oak and West Oak where the Water/Sewer Project taking place is being paved though grant funds and American Rescue funds through the city. Mayor Barlow stated Chris Bowdoin and Richard Peterson are going to speak on the options to add paving to these streets. Chris stated option A will pave 2/3 of South Oak Drive and a small amount of West Oak for no additional cost to the city. Chris stated option B paves <sup>3</sup>/<sub>4</sub> of South Oak and <sup>1</sup>/<sub>4</sub> of West Oak for no additional cost to the city. Chris stated option C paves 100% of South Oak and <sup>1</sup>/<sub>2</sub> of West Oak for a cost of \$47,000.00. Chris stated option D paves 100% of South and West Oak for a cost of \$71,000.00. Mayor and council discussed and will discuss at next council meeting.

Mayor Barlow stated the budget reports are in council's packet.

Mayor Barlow stated the Library Banquet on February 10, 2025 was great. Mayor Barlow stated the football banquet on the same night also had a great turn out.

Mayor Barlow stated Swamp Fest is March 8, 2025 starting at 9:00. Mayor Barlow stated the Gator Run would be that morning at 8:00 a.m.

Mayor Barlow stated Satsuma Boys Baseball opening day would also be March 8, 2025.

Mayor Barlow stated the Water Board will have a special meeting tomorrow night at 5:30 to discuss the bond issue. Mayor Barlow stated the bond refinancing is almost complete.

Mayor Barlow stated CPR classes are done and Michael Caldwell would be holding a make-up day at city hall on March 12, 2025.

Mayor Barlow asked George Fralic about the closing of ROW on Orange Ave.

Mayor Barlow stated advertising is needed for the Chapel, Steele Creek, and the Community Center.

Mayor Barlow stated the March calendar is in everyone's packet.
