# MINUTES OF April 15, 2025

# **Regular Meeting**

The City Council of the City of Satsuma, Alabama, convened in regular public session at City Hall in said city at 6:32 p.m. the 15th day of April 2025.

Mayor Barlow welcomed everyone and reminded everyone in attendance to turn all cell phones in the silent or off position. Everyone was requested to stand for pledge.

#### **Invocation**

Councilmember Little led the invocation and Pledge of Allegiance.

A quorum was present, and Mayor Barlow opened the meeting for the transaction of business.

# <u>Agenda</u>

On a motion made by Councilmember Reese and seconded by Councilmember Skelton, the motion carried unanimously the agenda was approved.

#### **Approval of Minutes**

Mayor Barlow presented the minutes from the Regular Meeting held on April 15, 2025. On a motion by Councilmember Little and seconded by Councilmember Butler, with all voting "aye" Council unanimously approved and the motion carried.

#### **Recognitions**

Swearing in ceremony for new firefighters, fire chief, police officer, and dispatcher was held before council. Mayor Barlow and councilmembers welcomed all new employees to the city.

# **Visitors**

Cleston Roberts, SHS Baseball, came before the council to request the waiver of fees for Steele Creek Lodge for the baseball banquet on June 23, 2025.

On a motion by Councilmember Phillips and seconded by Councilmember Skelton, with all voting "aye" Council unanimously approved and the motion carried.

Dena Zehner came to council to discuss, the "Y" at Baker and 43, the senior home on Baker being vacant for more than 2 years, the demolition of the senior home to make a park, Marlow Drive/Baker needing a crosswalk and 3-way stop, Marlow Drive needing paving, sidewalks down Marlow Drive, and neighbors not picking up dog poop after the dog poops in yards.

# Mayor's and Council's Reports:

#### Mayor's Report

Mayor Barlow expressed his condolences to several families on the death of their loved ones throughout the City of Satsuma.

Mayor Barlow stated the refinancing of the bonds should be finalized in the next couple of weeks.

Mayor Barlow stated Chris, Public Works Supervisor, is looking into the signs at North Gate and Baldwin Road area. Chris stated three additional signs are needed for that area.

Mayor Barlow stated a 3-way stop may be needed in that area. Mayor Barlow stated that it can be discussed at the workshop next week.

Mayor Barlow stated last summer the city had a clean up day. Mayor Barlow stated if everyone would like to have the event again, we can look into it. Mayor Barlow asked Jessica Jones to look into putting this event on again this year.

Mayor Barlow stated Tracy Robertson has expressed interest in serving on the Board of Adjustment and Mayor Barlow stated there is an open position.

On a motion by Councilmember Little and seconded by Councilmember Skelton, with all voting "aye" Council unanimously approved and the motion carried.

Mayor Barlow stated Goodwyn, Mills, and Caywood did a possible concept on the Community Garden Park in Vaughns. Mayor Barlow stated the map was in your packet if everyone would like to look it over and discuss it further at the workshop.

Mayor Barlow stated Thursday will be a busy day around the city. Mayor Barlow stated court will be held at 2:00 p.m., Planning Board has a workshop at 6:30 p.m., and the Municipal Dinner will be held in Chickasaw at 7:00 p.m.
